MEMORANDUM FOR: Whom It May Concern 14 April 2020

FROM: Meade County Highway Superintendent

SUBJECT: Rental of Meade County Equipment and Labor

REFERENCES: SDCL 31-11-28; SDCL 7-18-30; SDCL 7-18-31

- 1. Meade County affords other governmental agencies, non-governmental entities, and members of the public, the opportunity to rent County Highway Department equipment and personnel services. If the Highway Superintendent chooses to rent equipment and/or services to non-Meade County entities (government or otherwise), a separate contract will be entered into regarding the two parties to include dates, rates, and other unique conditions of the transaction to include condition of the equipment at issue vice the condition upon return. The Meade County Highway Superintendent will write the contract and it shall be approved by the Meade County Board of Commissioners in accordance with SDCL 7-18-31. All equipment rented to a non-governmental entity must be operated by a Meade County employee and associated equipment operator costs shall apply. Following are three sets of numbers. First, are the approved rental rates (in their entirety) from 2013; the last time the rates were set. Second, rental rates for other government agencies and third, rental rates (with an approximate 15% increase) for private, non-governmental entities. Rate revisions will be considered by the Board of Commissioners each year.
- 2. The Board of Commissioners approved the following rates via motion in 2013. The following is an exhaustive list of approved equipment and rates from said motion.

Meade County interests, as defined by the Highway Superintendent, will always supersede all others and the Meade County Highway Superintendent retains full authority to make all decisions regarding the rental of equipment and personnel services.
